1 GENERAL SCOPE OF WORK

a) Supply and delivery of the following Chemicals:

Item	Chemical Description	Level of Concentration
1	Hydrochloric acid (HCL)	33% wt. solution
2	Sodium Hydroxide (NaOH)	45% wt. solution
3	Poly Aluminium Chloride (PAC)	10% wt. solution

Contractor to provide :

- Transportation, operation, storage, maintenance, inspection and testing of the Chemicals
- Quality assurance and quality control testing.
- Chemicals to be supplied using adequate and fit for purpose tanker truck or iso-tanker and containers.
- b) Minimum requirements are as follows:
 - i) Valid Poison Act license(s) for the bulk chemicals
 - ii) Enclosed warehouse facility (owned or rent) minimum assessable area of 300m² to store chemicals
 - iii) Provision of trained personnel for the supply and delivery of such services eg trained driver(s) minimum Basic Chemical Awareness certification

 - v) Provision of storage for minimum 3 months usage of chemicals and deliver at timely schedules.
